

# Intro & Navigation Webinar Q&A's

### 1. How do you create Tabs?

To create tabbed views for your transactional screens – select the Intact logo on the bottom left of the screen i.e. Sales orders > Select settings > Change the settings within the Presentation mode overrides section to 'Tabbed'



## 2. How can I create a scheduled sales report on a daily basis let's say at 6 am?


In Intact iQ, nearly every master object, i.e. Customer, Supplier, Product, Lead, Prospect, etc. and every transaction type, i.e. Sales Quotation, Sales Order, Purchase Requisition, Purchase Order, Purchase Invoice, etc. can have a Workflow Status assigned to it.

A Workflow Status is a convenient method of controlling the flow of an object from initial recording to final approval for acceptance into Intact iQ. In the case of a transaction, a Workflow Status can be used to track the various stages of its processing from initial logging to completion. In the case of customers and suppliers, a Workflow status could be used to identify active accounts from dormant accounts.

Intact iQ also has a Transaction Authorisation Request facility which can only be setup where the Agility Module has been purchased. Workflow Statuses reduces the need to use this facility for every transaction.

Workflow Statuses can be a component of the overall Security Policy implemented by a company.
